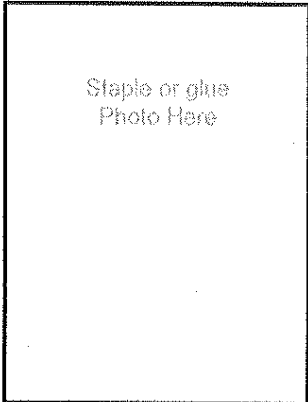

- Completely filled out **one application form**. Please fill out the application and **sign** before sending.
- Two (2) recent photos (30mm x 40mm) against white background.
- Proof of valid resident status in Canada for non-Canadians
- if you travel for business:
 - a) Letter from the employer, stating the purpose of the trip
 - b) Copy of the Incorporation Certificate of the company
 - c) Return ticket copy
- Copy of the approval letter from the Immigration Office in Indonesia should the duration of stay is more than 6 months.
- prepaid **FedEx/UPS/DHL/Purolator** envelope if you need your passport couriered back to you. Alternatively, add \$25 to the total price for courier delivery within Canada or \$35 for US
- Payment: request to charge your credit card, or certified cheque, or money order payable to **RCTC Corp** for the specified amount, depending on visa type and delivery.
- Filled-out and signed informational sheet and credit card authorization (if paying by credit card)
